

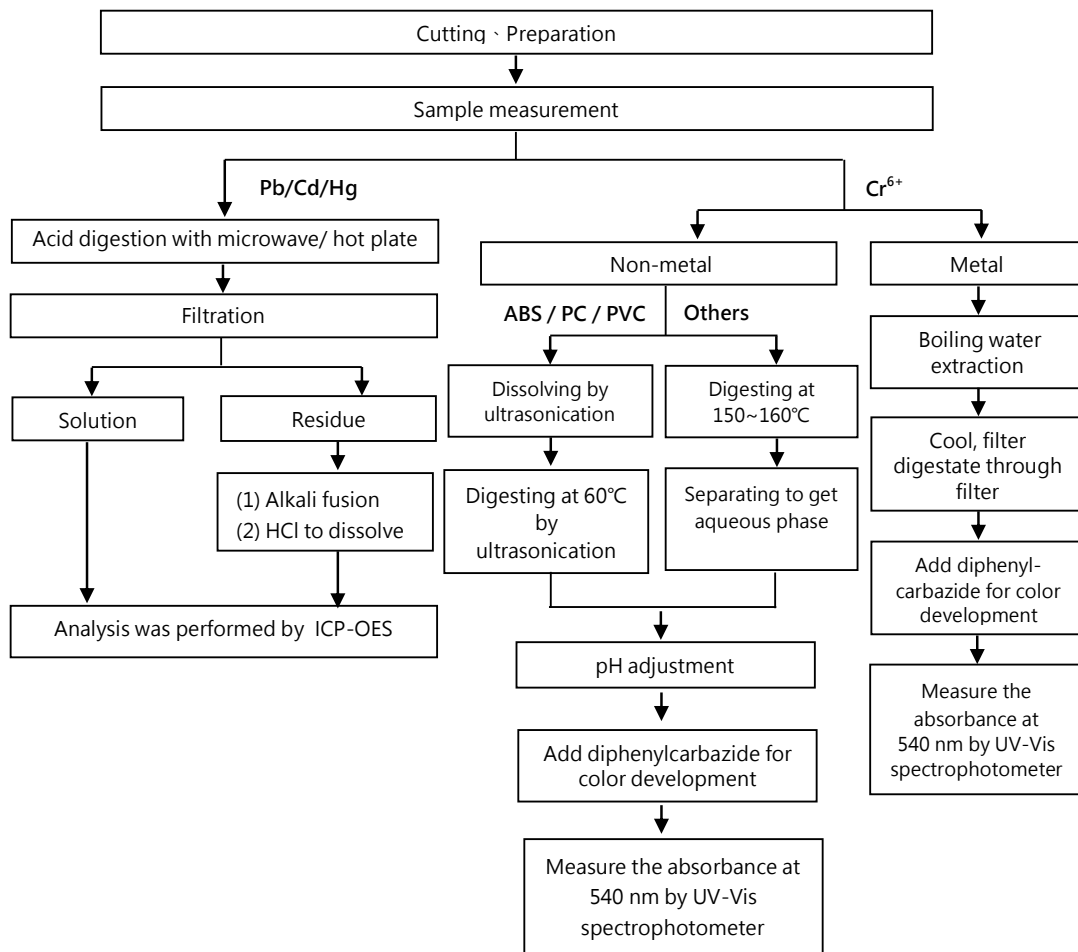

## Analytical flow chart of heavy metal

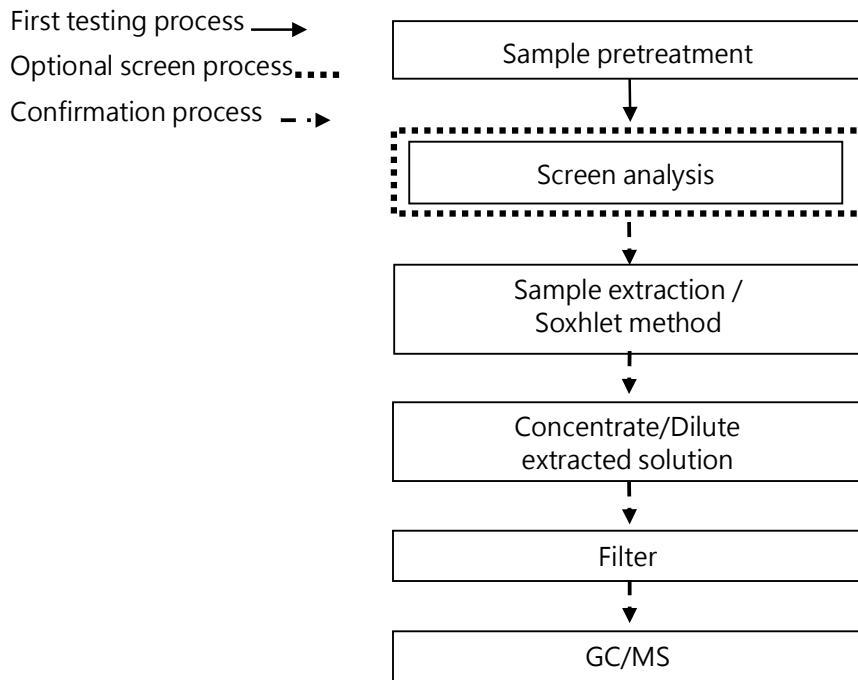

### Analytical flow chart – PBBs / PBDEs

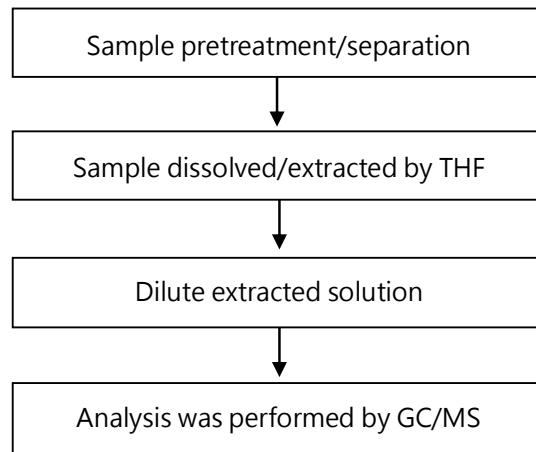

## Analytical flow chart - Phthalate

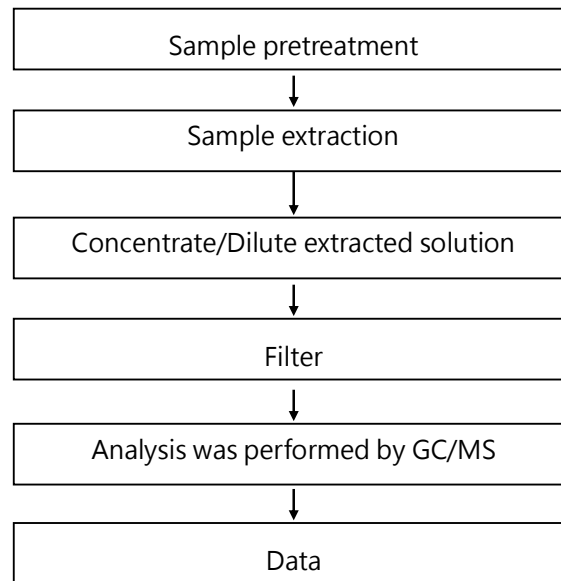

### Analytical flow chart - HBCDD

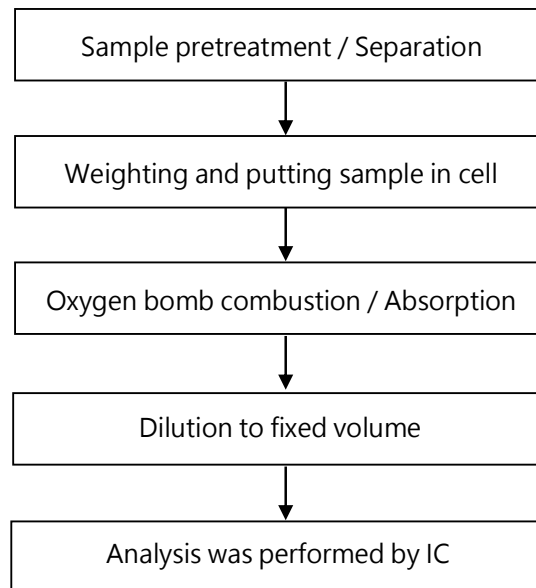

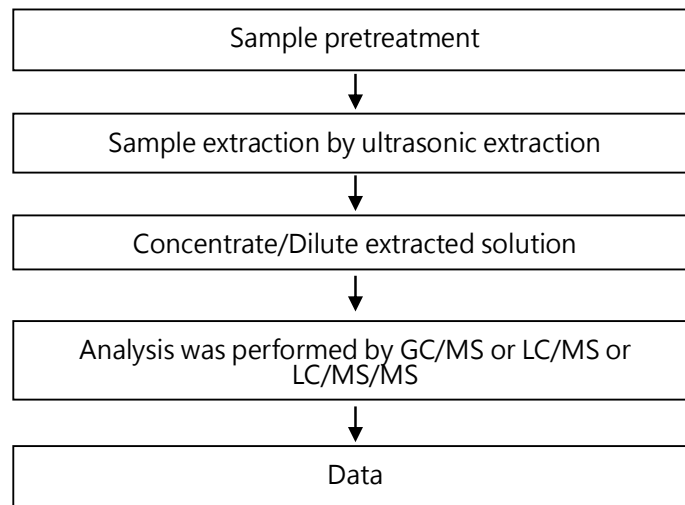
### Analytical flow chart - Halogen

### Analytical flow chart – PFAS (including PFOA/PFOS/its related compound, etc.)

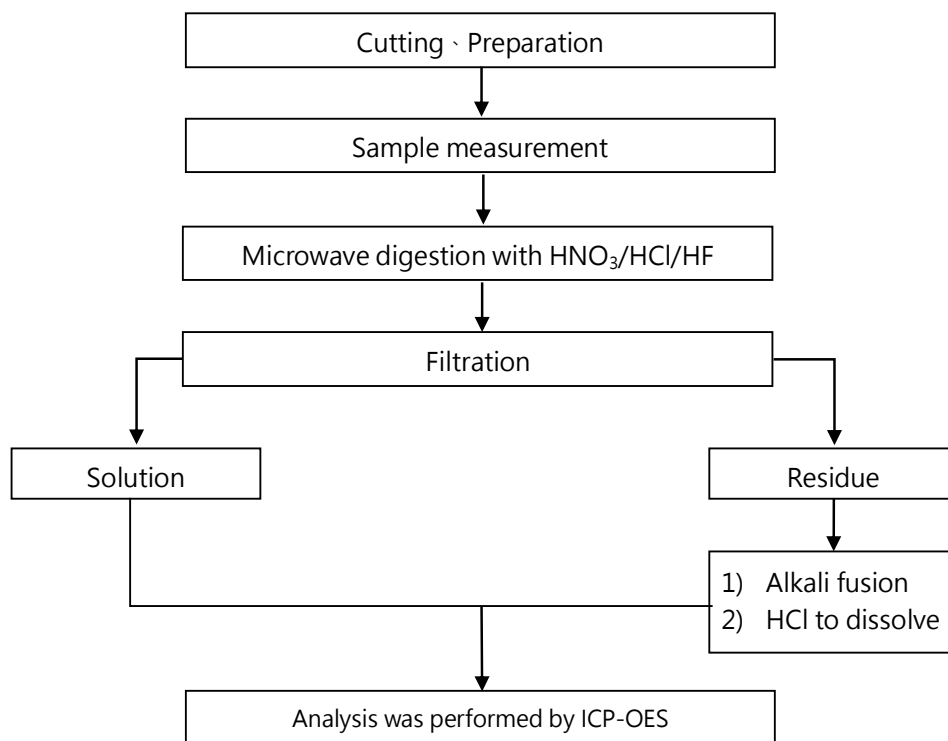

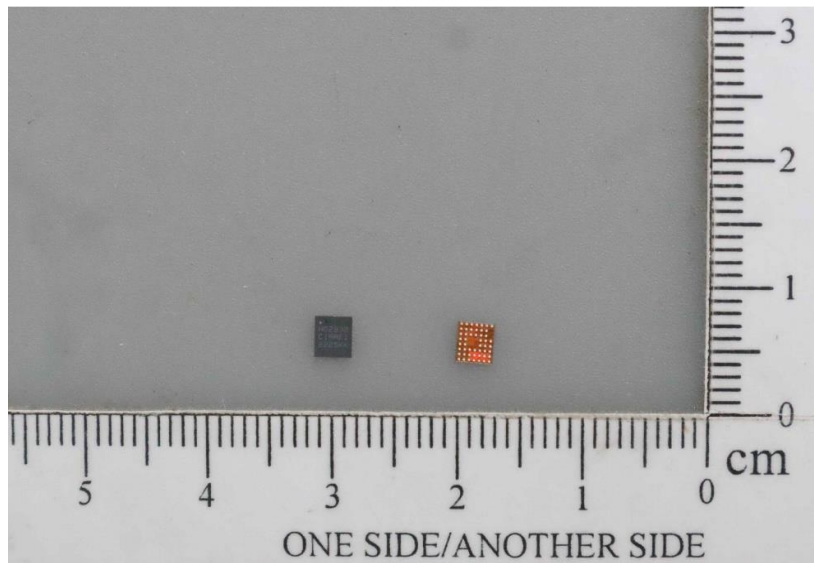
