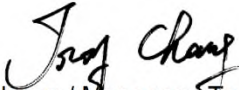

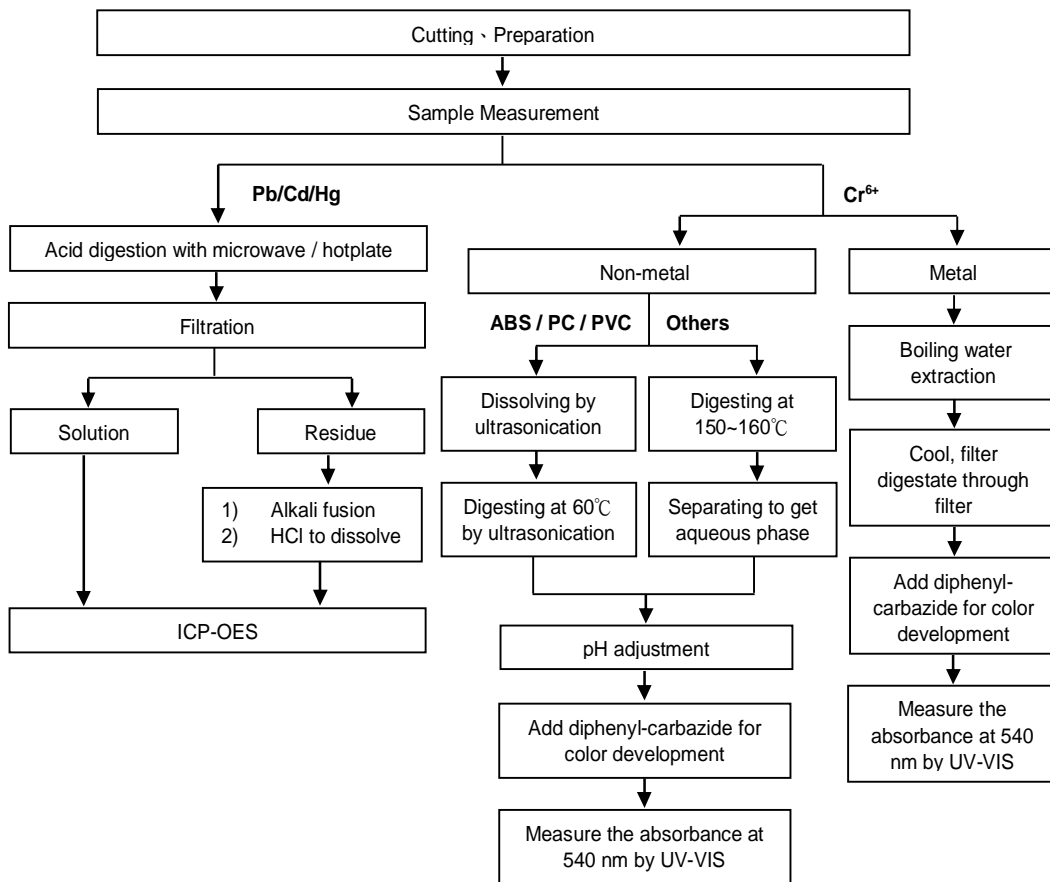

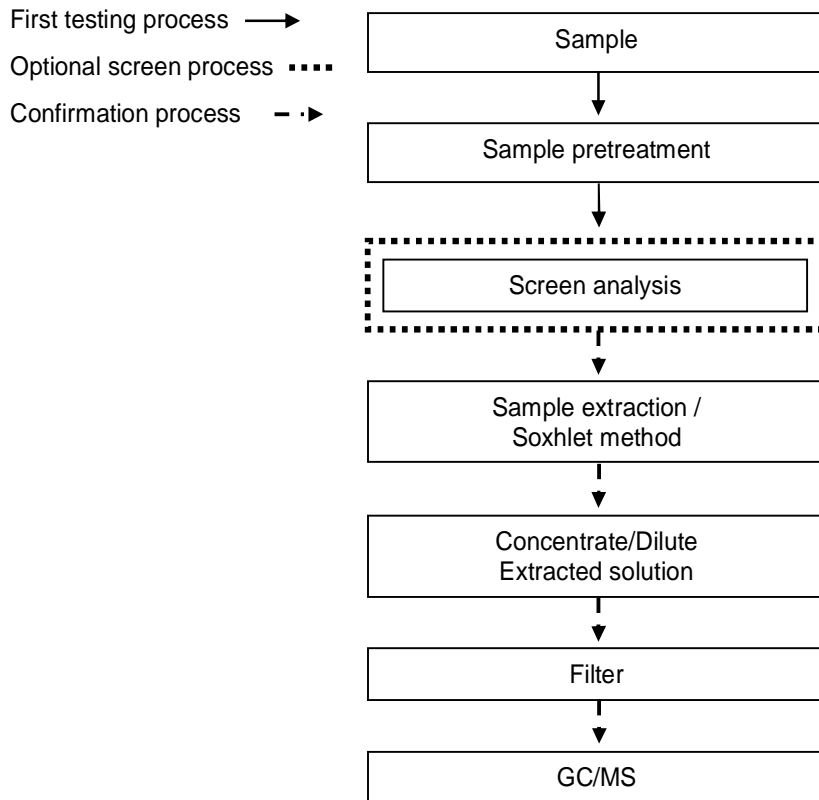
### Analytical flow chart of Heavy Metal

### Analytical flow chart – PBB / PBDE

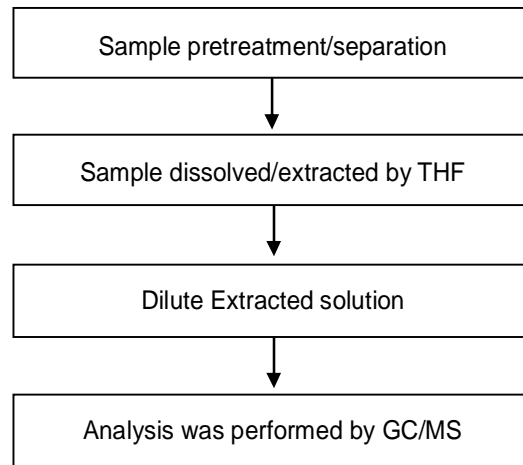

### Analytical flow chart - Phthalate

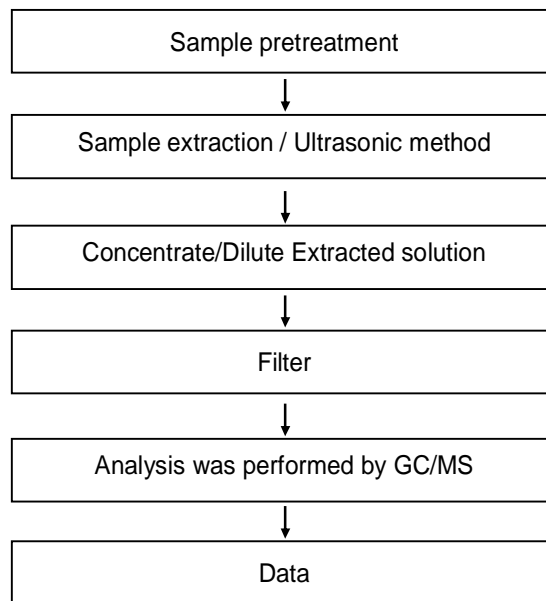

### Analytical flow chart - HBCDD

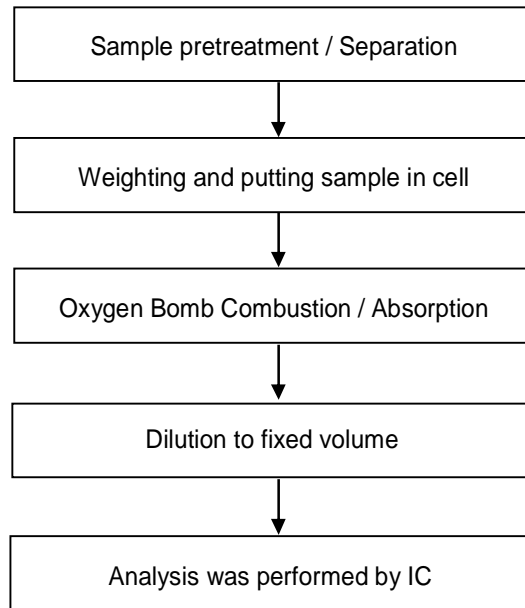

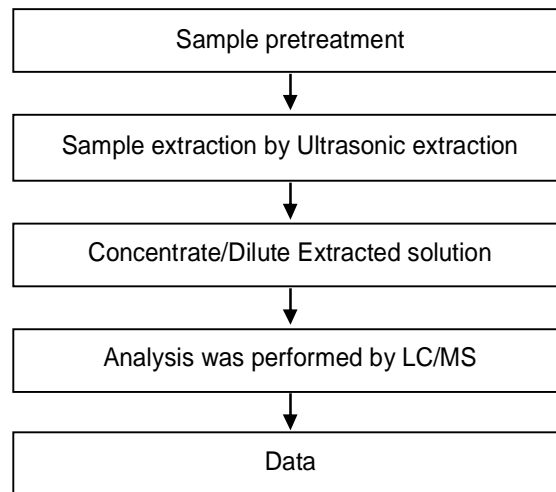
**Analytical flow chart - Halogen**

### Analytical flow chart - PFOA/PFOS

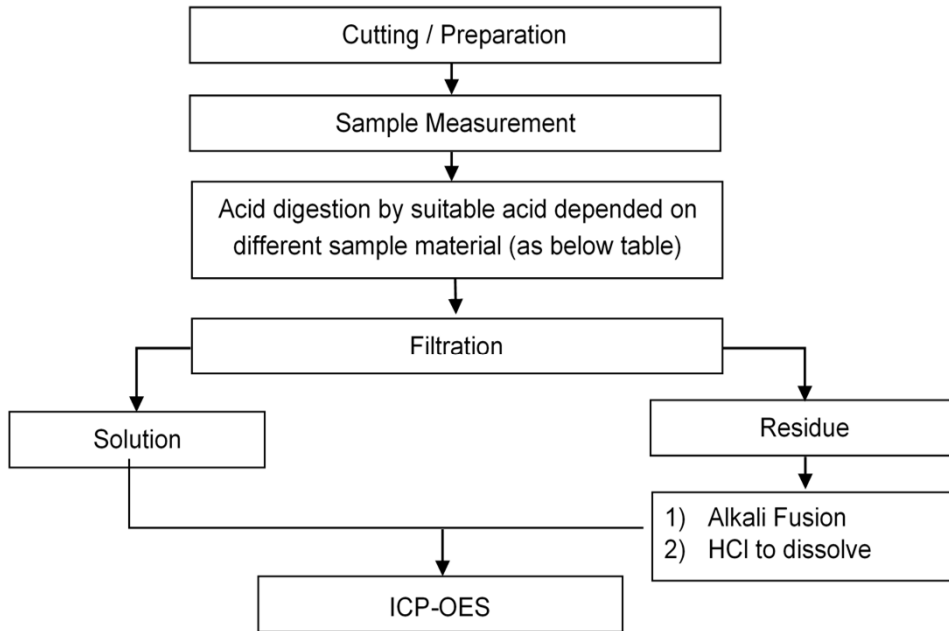

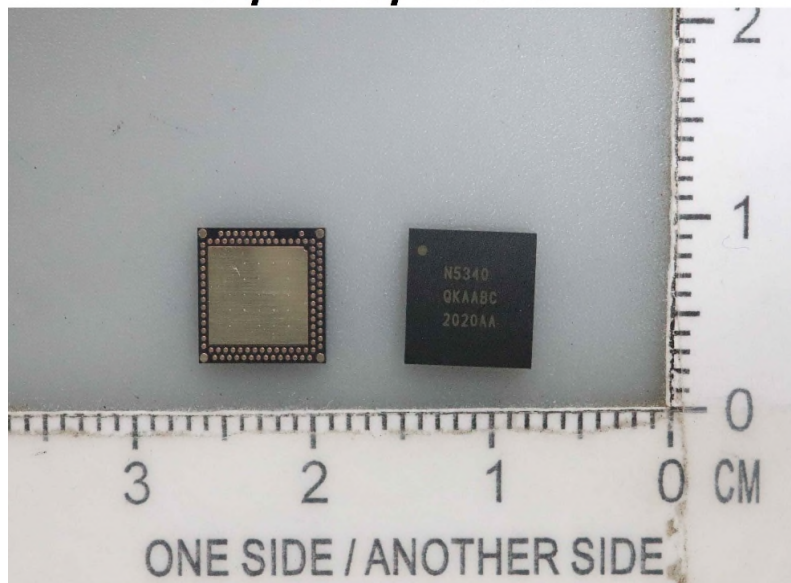
