Nordic Semiconductor generally adopts copper as standard wire-bond material for QFN assembly. Devices previously employing gold bond-wires were converted to copper in a broad conversion program documented in previously issued PCN-059, however due to its state as prototype at the time, the nRF8001-R2Q32 was omitted from this process. The copper wire-bond process for the applicable package type can generally be viewed as thoroughly proven through PCN-059. Further, as for devices subject to PCN-059, the change has been qualified according to Nordic Semiconductor's standard product approval and quality. Samples can be provided upon request.
